We are thrilled to announce our Advanced Training on Friday, **January 31, 2020**, and to be together with you all again. Remember that all those who have completed an approved 20 hours of Rainbowdance with 15 hours of leading are eligible to attend. Make sure your time sheets have been signed! If you are a few hours shy of that number, contact Rachel or Dicki to discuss your eligibility.

Reaching Advanced status will:

- Make you a part of our endorsed practitioner list on our website, and a part of our referral network
- Give you ongoing supervision both live and online
- Give you first access to current research and developments in the program
- Train you in the advanced level of preschool and elementary groups and the improvisational model (transition to kindergarten program)
- Give you first chance at future specialized trainings
- **NEW:** Endorsed Rainbowdance Practitioners will now be credentialed to offer Rainbowdance Orientations to current staff/parents of clientele
- **NEW:** To all newly and current Endorsed Practitioners who have paid their annual licensing fee, a 50% discount on all BCF workshops and RD booster trainings. New workshops will be added to the offering menu

After you reach the Advanced status, there will be a yearly \$100 fee to maintain this standing which will be due each December for the upcoming year. If you are interested in buying a Rainbowdance kit please include that in your registration. You will also be required to accrue 6 BCF CEU's annually, which you may acquire by taking one of Dicki's day-long dance intensives.

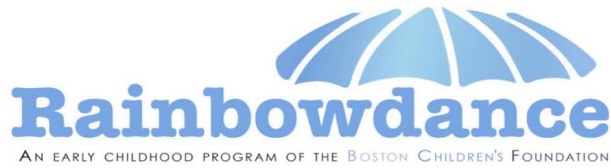
Thank you for your continued work in the field and at your sites. It's a pleasure to work with all of you and continue to build this great circle!
